Terms and Conditions for Participation

Definition

Expo Design 2010. The exhibitor shall mean the party to whom registration of Expo Design is offered and the "Organiser" shall mean Manch Communications (P) Ltd

Obligation

An exhibitor is bound by the conditions of participation and Rules & Regulations issued from time to time by the organiser and is obliged to enforce compliance there of from his staff, agents or representatives.

Incase of cancellation or withdrawal from participation the exhibitor amount paid by him will be forfeited.

Rights of Organiser

- To reject any participation without assigning any reasons.
- To amend these conditions for participation and additional Rules & Regulations for participation from time to time, this shall be binding on all participants.
- To postpone, curtail, extend or abandon the summit or close or some or all section of it temporarily or permanently, if unforeseen circumstances so require, in such an eventuality, no exhibitor shall be entitled to withdraw from the contract or to claim any compensation or damage.

Permission/ Approval

All verbal agreement, permission, individual approvals or special authorization shall be deemed to be valid only if confirmed in writing by the organiser.

Force Majeure

Under the condition of force Majeure, which also includes strike, lockout, closure, riot, the organisers reserve the right to alter the opening dates and duration or curtail, cancel or suspend in whole or part of the summit. In such an event, the exhibitor is entitled neither to rescind the contract nor to claim any compensation or damages. In the proportionate cost already incurred by the organisers and the cost of any additional services provided to the delegate.

Final Decision

Incase of any dispute in interpretation of condition for participation, or between exhibitors, the final decision will be of the organisers namely Manch Communications (P) Ltd

Domicile & Jurisdiction

The implementation of these regulations or supplementary stipulations laid down by the organisers relating to the summit shall be deemed to be domiciled at the office of the Delhi courts. All disputes arising shall be judged according to Indian Laws and Subject to Delhi jurisdiction
